The Board of County Commissioners of Mineral County, Montana met in regular session on Friday, July 19, 2019. Present were Board Chair Roman Zylawy, Commissioner Laurie Johnston, Commissioner Duane Simons and Administrative Assistant Dawn Terrill.

Sand Screen Bid Opening

Present: Jason McLees- Road Department

Two bids were received:

Jason McLees read the first and second bid:

Green Mountain Construction for producing and stockpiling 3500 cubic yards of road sand at \$6.43 per yard for a total of \$22,505.00

M.I.H. Construction LLC to stockpile 3500 yds in his pit at Dry Creek for \$6.15 per yard for a total of \$21,505.00

Commissioner Simons made a motion and Commissioner Johnston seconded to accept the bid from MIH in the amount of \$21,505.00 based on the recommendation of Road Foreman Jason McLees. Motion carried unanimously
