COPS Grant Discussion

- this is a three-year grant, offering up to \$125,000; the sheriff's office asked the -grant to pay the full cost of an officer which would include salary and fringe benefits, clothing allowance, shift differential and holiday pay
- because of the request, \$223,00.00 was awarded
- the grant requires a commitment to keep the officer hired for one year at the end, with the total cost being paid by the county
- must be an entry level officer
- the focus of the grant is community policing; combatting violent crime
- the grant starts July 1, 2020, ending June 2023; financials are due every three months, reimbursement is quarterly, and a status report is to be turned in every six months
