The Board of County Commissioners of Mineral County, Montana, met in regular session on Friday, November 13, 2020. Present were Commissioner Roman Zylawy, Commissioner Laurie Johnston Commissioner Duane Simons, and Administrative Assistant Dawn Terrill.

Commissioner Roman Zylawy called the meeting to order at 9:00 AM.

Sheriff Toth- Possible Action Item(s)

Present: Mike Toth -Sheriff and Ellen Donohue- County Attorney were present via teleconferencing

Mike-

- Mark Neu made signs for the Mickey O'Brien dedication center for a fee of \$1400.00
- asks about the status of hiring two detention officers previously interviewed/Response-yes;
 later the response is to hire one and conduct new interviews as several more applications have been turned in to HR
- states the county has to figure something out with the Health Dept regarding law enforcement and quarantine; this can't happen again; the citizens will be more in danger by not patrolling than us exposing them to COVID
- Jenn Donovan must make phone calls and find the answers to working around the fourteen-day quarantine
- States there are some issues with the COPS grant and Stone Garden grant also
- one new hire going to Academy for jailer's school
- remember: DOT offered to send trainers, needs phone numbers to contact DOT
- also needs a senior dispatcher with appx five years' experience to train appropriately; would like to advertise for a full-time head dispatcher to take charge

Ellen-

- the sheriff's department has to come up with a policy to lower the risk of law enforcement using fewer people per incidence
- reinforces the necessity of following the quarantine law
- states we must make sure the people being cared for by law enforcement are not exposed by law enforcement
- stresses the fact that it is up to the sheriff's office to put together a plan

- invites the sheriff to begin attending Board of Health Meetings; he was invited to attend the November 6, 2020 meeting
- asks that the sheriff gives more information for the agenda so the community can attend or comment/Response: agreement

Roman-

- is looking for a way to let people come back to work when not positive
- two counties are letting their law enforcement work around the quarantine- asks how this is being done

Duane

- believes the quarantine mandate is from the governor, not the health department
- states that any exceptions must be in writing
- asks Mike to get in touch with the two counties regarding breaking the quarantine, and Ellen
 offers to contact the health department to ask the health departments about the two
 counties said not to be following quarantine mandates as we know them

Laurie-

- how many actively working detention officers? /Response- two; would like two more hired, two
 moving from Dispatch will make six- would like seven
- asks if Keith will be able to come in and go over some jail things /Response: Yes

- fire/seasonal hiring is in process
- tells that the Nightriders are working with the Health Dept for their annual poker ride event
- is checking on forest service legal responsibility for plow permits requested by real estate firms and property buyers past Packer Creek Rd, which is a groomed snowmobile trail
- looking at veg management in campgrounds at Quartz Flat and Sloway
