Present: Kelly Morrison-citizen.

Kelly asked how much has been paid to the Court appointed Court Supervisor to date? Also: where is the formal process in writing for a person to follow when submitting a claim. Where can county job descriptions be found, and where is the county employee formal complaint process in writing. Kelly also asked. When will the county employee handbook manual be rewritten? And who will be writing it. She asked specifically, when will Commissioner Terrill's term expire on the library board of Trustees. Lastly, Kelly said that someone had given her a statement to read, but she decided she would not read the statements of others.

Present: Kelly Morrison-citizen, Anna Marie White-citizen, Amy Parks- DES coordinator, Wayne Cashman- Undersheriff, Ryan Funke- Sheriff, Mistydawn Holyoak-Dispatcher.

Mistydawn talked about the great need for the new console because the old one is so outdated; they can no longer acquire parts for it. She would like to receive \$ 60,000 dollars for new console and

additional \$140,000 dollars to start on repeater upgrades. The repeater work would not include fire and ambulance upgrades, but would make the Sheriff's office able to adequately communicate until full upgrade could happen. Mistydawn said she spoke with Emily who suggested they look at using Title III funds for the entire \$200,000 dollars. There is and issue however, as to whether title III funds are allowed for that type of expenditure. Sheriff Funke said that we should be able to state this is an emergency and bypass some of the normal procedures in the procurement process. And if ARPA funds are used, the process can be lengthy. Commissioner Simons asked about the status of using the SMART grant monies. Mistydawn said that Emily told her it would be about two weeks before knowing anything there. The Sheriff would like to start with fixing the console, and then make incremental improvements from there.

Commissioner Zylawy moved, and Commissioner Simons seconded to approve the new console and repeater upgrade with \$ 200,000 dollars coming from the ARPA fund, contingent upon Emily Parks approving the procurement procedure for the Sheriff to follow.

Also, as part of organizing the Board: selecting a chairperson. Commissioner Simons liked the job being done by Commissioner Terrill and thought she should do it another year. In addition to the approving of the respective boards assigned to Commissioners, he recommended Commissioner Terrill be the Chairperson for 2024.

So, then the day of Wednesday was discussed. All were leaning towards selecting Wednesdays until Commissioner Simons checked with the payroll and claims office. Getting those tasks completed by a Wednesday meeting day deadline was deemed too difficult. So the meeting day of Friday became the best.

10:35 AM- 11:15 AM Forest Service update- Superior Ranger Abby Lane and Nine mile Ranger Chris Gauger.

Present: Abby Lane- Superior Ranger, Chris Gauger-9-Mile Range.

Ranger Gauger spoke about the prescribed burns performed successfully last fall and the ones planned in the Spring. He said that the 9-mile district has a full staff of fire crew and also a new Wildlife biologist. The Great American Outdoor Act has funding that will be used for water systems projects in places like

Savennac and other campground sites. And Fish creek road is being improved with new gravel and roadwork. The Sawmill/Petty sale has four different sub-sales with separate funding and roadwork packages. The Soldier Butler sale now has a FWS opinion and recommendation that can hopefully go back to court with and release the injunction against them. The 188 stock mules and horses that are boarded at 9-mile are still there, 31 of those belong to the 9-mile district. Ranger Gauger also mentioned that the Rocky Mountain Elk foundation is interested in brokering a land purchase of several thousand acres in Mineral County, and then having Forest service acquire it as public land. Next: Ranger Abby Lane from Superior District spoke. She said that the RAC (Resource advisory committee) was approved to have a charter and begin meeting. Since they have been inactive for a few years, they now have \$300,000.00 dollars to start with. Abby also talked about the status of several timber sales like Redd Bull, Superior North, and Two Fish. A newly hired Fish Biologist is also now in Superior. The North Fork of the Little Joe Road will have major roadwork done this summer and will be closed for approximately six weeks for a bridge/culvert replacement. The Lolo Forest plan release date and proposed action will be out sometime next month.

11:15 AM – 12 Noon Request to approve Petition to vacate an alley located in block 6: lots 1-6 of Mayo's addition to Deborgia book of Townsites- ACTION ITEM- Andy Short, Environmental and Planning office.

Present: Brooke Lincoln-citizen, Andy Short- Environmental and Planning, Mark and Mary Devine-citizens, Mark Veilleux-citizen, Sharon Fuhrman-citizen, Christopher Colon-citizen, Candis Hampton-Environmental Planning office, Wally Congdon- Mineral County Deputy Attorney, Sean Cielke-citizen, Amy English-citizen.

And Short started out by saying how after receiving public comment and has findings of facts regarding the petition. It was signed by several area landowners who would like to vacate the alley in Deborgia; they include- Mark Veilleux, Christopher Colon, Victor Colon and Sharon Fuhrman. The Public notice of the Petition was posted on 9-27-2023 and on 1-3-2024. The townsites and alleys were platted in 1912 and this particular spot has never been developed as an alley. There was a protest received from an attorney Nelson Swanson, representing Sean Cielke of Deborgia. Sharon Swanson spoke about how she purchased the land in 2008 from Brooke Lincoln and thought that the alley had already been vacated then. Brooke spoke how she owned the lots east and across the road and had vacated that alley in early 200's. Apparently she believed it included the alley west of the street as well. Today, Sharon Fuhrman's water lines run under and across the alley, and she put it there thinking the alley was closed. Sean Cielke spoke how he wants the alley to remain open because he occasionally uses it to access his property. And if it's a public alleyway, then he has the right to do so. Even though today it looks like part of people's land, yard and property, Cielke says he would voluntarily use his own equipment to transform it into a street worthy alley complete with gravel/dirt material for a road surface. Mary Devine asks: after all of these years, what is the purpose of making it an open alley now? Christopher Colon stated that it Dead ends right in front of his cabin and there is no need for it to be open. Mark Devine said that he found and old rusty horse bit that was probably from early 1900's, thereby proving that it hasn't really been used as it was intended. Wally Congdon wants time to research other letters to vacate in the Deborgia townsites, as well as documents and old surveys.

Commissioners Zylawy moved, and Commissioner Simons seconded to table the decision to allow time to better research the subject. All in favor. Motion carried.

Denley spoke about how important it is to have a natural resource advisor working for the county. He also talked about highway 135 and a need for a study for the St. Regis four-way stop and increased traffic on the Cutoff Road. And regarding the court decision that Governor Gianforte must allow his veto of SB 442 to be considered for an override through polling of legislators, he believes it will be overridden.

Bessie spoke on the need for animal care of abandoned dogs and cats, and how a cement pad kennel near the county shop or somewhere central would be helpful. Currently it is all volunteers who take in and care for abandoned animals. In 2018 the County did pass a resolution to address vicious dogs in the county, but the County Attorney at the time did not ever complete the enforcing ordinance to finish the process. So today, we still don't have any regulations for animals other than what exists in State law. Wally said that every animal must have a rabies shot and suggests that dogs be chipped so current vaccination records can be quickly obtained when there is an incident. Bessie said that she has two microchip scanners purchased through a Go Fund me drive, and wants to have one available at the Sheriff's office for the Deputies and dispatch. Bessie also suggests that for people arrested with an animal, that they should be billed a daily rate for the care of their animal while in jail. The discussion was long and some issues were complicated, so it was decided that a committee be formed to fine tune the ordinance before adopting. No action was taken pending the committee recommendations.

Diane talked about the RARE (Rebuilding America's Infrastructure Sustainability Equity) grant and how it ties together a rail to trails path to the west coast. The Interlocal agreement with five other counties will

work to address completion in the western part of Montana. The Interlocal agreement is with Butte Silver Bow, Powell, Granite, Missoula and Mineral Counties. The grant does require a \$1,000.00 dollar contribution, and Heather Burman with the Forest service has agreed to provide the funding for that. So this would be a zero dollar contribution from Mineral County. The portion of the trail that they are focusing on is a two-mile section between Crystal Springs and Tarkio through some DNRC property. And they have rules regarding motorized use for permitted projects on their land. There was some discussion about electric bikes and electric wheelchairs, and whether they might be allowed. The Grant will pay 100 percent for the preliminary engineering report that is required.

Commissioner Simons moved, and Commissioner Zylawy seconded to approve the Rail to Trails Interlocal agreement with Five other counties for the Grant. All in favor. Motion carried.

Lance presented copies of the Settlement agreement regarding the Writ of Mandamus filed against the Sheriffs Office and the County Attorney's office. He also presented a copy of the Court Supervisor's report written by Bob Long. Additionally, Lance submitted an invoice itemizing telephone conversations, e mails, time reviewing and finalizing reports that he said could also be considered by the court for further payment. The total of his itemized invoice # 24461, came to a total of \$20,817.90 dollars. All of the new Invoice charges occurred after the May 26, 2023 Settlement agreement and have not yet been turned in to the court for consideration. Lance said that he believes the charges are necessary due to ongoing obstinance from the County attorney in cooperating and working with attorneys on Mineral County cases and requests for speedy trials. Lance said that even the Court Supervisor was having difficulty getting cooperation from the County attorney. He said that the public defender's office has asked him to take over their cases, so they could be expedited. He said that there is still friction between the Sheriff's office and County Attorney's office and it is interfering in cases that need to be resolved. Not every case needs to go to trial. Some can be plea bargained and taken care of that way. The County having to spend an extra \$ 20,000 dollars due to no cooperation is something that is unnecessary. Lance said he is going to ask the Judge to award the new fees and is thinking about donating the money towards the Pool in the Park project. Lance refereed to a 4-step process outlined by Bob Long to have County Attorney better disclose on unqualified law enforcement, employ better qualified people, reduce the workload by accepting some plea offers, and making sure the two offices stay in their respective lanes regarding the duties of their own offices. Lance also believes that there is still some retaliation happening in regards to Deputy Micah Allard, and that it needs to stop. Diane Magone asked what exactly was the writ's purpose, and did it do any good. Lance replied, the \$ 20,000 dollar invoice is primarily for follow up with his clients, and the writs were necessary to get both offices into compliance of their correct job duties. He said that things are basically 95% good now, but with 10% still needing work. Wally spoke and said that he thought that the Writ was done by ambush. He also wanted to know what things had the office not yet done exactly, that need to be done. He said that the County

attorney's office had not had any communication with Lance and feels blindsided. The county attorney's office is playing by the rules, but it's not always being done by the other side. We have not shredded any evidence, he said. Deb Jackson said she would very much like to comment on things, but she feels she is too angry at the moment. She said she can better express herself when not so upset. She wants to schedule a public meeting on the agenda for her response at a future date. Anna Marie white asked what the amount was for the Court Supervisor. Commissioner Terrill replied: \$ 14,000 dollars. Ken Verley asked for the total cost so far. Commissioner Zylawy responded to the question with: \$100,000.00 dollars to Lance Jasper's Firm. \$30,000.00 dollars to Sheriff Funke's attorney, Paul Leisher. And \$14,00.00 dollars for Bob Long, the Court appointed Court Supervisor.

MistyDawn said that four bids were submitted responding to the advertised request for new console and some radio repeater/tower work. She said that the four companies submitting were:

- 1- Dunne Communications, Anaconda MT for \$188,877.64 dollars
- 2- Valence from Spokane WA. For \$146,926.18 dollars
- 3- Redtail Communications, Missoula MT. for \$141,164.00 dollars
- 4- GCS (Gold Communication Services) Kalispell MT. for 199,654.79 dollars.

There was a lot of discussion regarding the bids and comparing their differences addressing warranty, the cost for training dispatch personnel on new console, as well as the brand of the radio equipment and past response time of companies to emergent needs during radio failures. After talking about the bids with the Sheriff and his lead dispatcher for an hour, there was a recommendation from the Sheriff and a motion from the board. Commissioner Zylawy reminded the Sheriff that the previously approved ARPA funds for the radio was in the amount of up to \$200,000.00 dollars. And that should the bidder exceed that amount, there wouldn't be enough to cover the project. The Sheriff understood and stated that if there was an overage amount exceeding the ARPA approved amount of \$200,000.00, that he would use his remaining CARES ACT money to cover it.

Commissioner Simons moved, and Commissioner Zylawy seconded to award the bid to GCS from Kalispell MT. for \$199,654.79 dollars. All in favor. Motion carried.
